1. David & Brenda Colley- application requesting a Rezone on 4.538 of 9.688 acres Map/Parcel 008/093 from AR (Agricultural Rural Residential) to A2 (General Agricultural) for the purpose of selling 4.538 acre parcel to a neighbor to combine with Map/Parcel 021/035 containing approximately 20.16 acres. The property is located on Parkview Road also known as CR 61.
2. Forest Kellogg- application requesting a Rezone on approximately 3 acres Map/Parcel 017/001 from AR (Agricultural Rural Residential) to A2 (General Agricultural) for the purpose of combining said property with Map/Parcel 017/002 which contains approximately 90.64 acres and is zoned A2. The property is located on Lower Wirebridge Road also known as CR 87.
3. George Mattox- application requesting a Conditional Use for non-commercial recreation on 1 of 74.71 acres Map/Parcel 125/042 zoned A2 (General Agricultural) for the purpose of donating said 1 acre parcel to Thankful Grove Baptist Church. The property is located on Lexington Carlton Road also known as CR 315.
4. Mary Smith- application requesting a Rezone on .535 of 103.12 acres Map/Parcel 061/026 from A2 (General Agricultural) to R1 (Single Family Residential) for the purpose of selling the .535 acre parcel to a neighbor to combine with Map/Parcel 061/030 containing approximately 1.005 acres to make a conforming lot. The property is located on Main Street also known as SR 77.
5. Jonell Steele- application requesting a Rezone on 11.5 of 179.67 acres Map/Parcel 085/005 from A2 (General Agricultural) to AR (Agricultural Rural Residential) to be sold; the rezone of 2.25 acres to be combined with Map/Parcel 085/006 containing approximately .75 acres and will also be rezoned from A2 to AR to form a new parcel containing 3 acres; the rezone of 2.19 acres to be combined with Map/Parcel 085/003 containing approximately 1 acre to form an AR parcel containing approximately 3.19 acres; and a variance for the creation of two AR parcels containing less than 5 acres. The property is located on Union Point Road also known as SR 77.


